# PATIOSEAL

## Sealer for protecting paths and patios

### Description

*A solvent-free, acrylic liquid used to seal and protect patios, paths, natural stone, concrete and block paving from sunlight, water, oil, petrol and fungal/moss growth.*

### Uses

Protects block paving driveways and pathways and patios against water penetration as well as spillages of contaminants, such as oil and grease. It will also deter dirt and grime build-up and will enhance both the present colour of the paths and greatly extend the lifespan of the driveway.

#### Benefits:

- Solvent-free formulation - low odour.
- Facilitates easier cleaning.
- Improves water resistance and UV resistance.
- Contains fungicide which retards mould growth.

### Preparation

Remove any moss or lichen that may be present. For best results use Bond It MOULD AND MILDEW WASH or MOSS-STOP!, refer to the appropriate data sheet. Wash all debris away and ensure the surface is dry and free from oil, grease, dust and loose material that may hinder adhesion.

### Application

Bond It PATIOSEAL is ready to use, and does not require diluting. Shake well before use. Ensure that the surface is completely dry. Apply using either a brush, roller or squeegee, ensuring no pooling or ponding occurs. We recommend a two coat application allowing 3-4 hours between coats. Minimum application temperature above 5°C.

### Limitations

Do not apply Bond It PATIOSEAL to wet surfaces or in conditions of high humidity. Do not use when rain is forecast (protect from rain until dry). Do not apply to non-porous surfaces. Keep children and pets away from treated areas until fully cured. Do not allow any run off to contaminate drains, waterways or plants. It is the users responsibility to determine suitability for use. If in doubt, consult our Technical Department for further details.

Areas treated with this product can be cleaned with warm water and detergent or Bond It MOULD & MILDEW WASH. Do not use acid based cleaners, as these will remove/discolour the product. Also avoid using power washers.

### Storage Conditions

Store in cool, dry conditions in original sealed container. Keep away from direct sunlight and protect from frost.

### Shelf Life

12 months when stored according to manufacturers instructions.

### Coverage

Approximately 5-7m<sup>2</sup> per litre depending on surface porosity.

### Disposal of Containers

Do not leave empty containers where residue could be harmful to children, animals or the environment. Replace lids and remove any containers to a central disposal point in accordance with local regulations.

### Health & Safety

- ◆ Product presents a low hazard in correct use.
- ◆ Avoid eye contact. In the event of contact irrigate eyes immediately with plenty of cold, clean water for 15 minutes and seek medical attention.
- ◆ Do not ingest. In the event of ingestion, do not induce vomiting, drink plenty of water and seek medical attention.
- ◆ Thoroughly wash hands with soap and water after use.
- ◆ Keep out of reach of children.
